INTRODUCTION

An Overview of the Registration Department

The Registration Department is segmented in its functions and has the following sections:

1. **The Supreme Court** which comprises:

1. The Court of Appeal
2. The High Court

Court of Appeal is presided over by Justices of Appeal and mainly deals with Appeals from the High Courts and Magistrates' Courts. The Chief Justice is President of the Court of Appeal.

The High Courts are presided over by Judges of the High Court and deal with Civil and Family matters as well as Criminal offences that are committed for trial by the Magistrates' Courts.

2. **The Magistrates' Courts**

The Magistrates' Courts are courts of summary jurisdiction where a Magistrate acting without a jury conduct cases without delay or formality. Magistrates' Courts are located at the various districts throughout the island.

3. **The Court Process Office**

The Court Process Office has responsibility for the execution of Writs, Orders, Levies for debt and serving of Summonses and other documents or process required to be served by the Rules of the Court. Its authority is derived from the Court Process Act Cap. 11A of the Laws of Barbados..

4. **The Records Branch**

The Records Branch also referred to, as the Island's registry is responsible for the registration of vital statistics records, i.e. births, deaths, marriages and professional registrations.

The Registrar of the Supreme Court is responsible for the administration of the Registration Department.

Functions:

The functions of the Registration Department are set out in various pieces of legislation.

These are:

- The Supreme Court Act (Cap 117A)
- The Supreme Court Rules

- The Magistrates' Courts Act (Cap 116A)
- The Court Process Office Act (Cap 111A)
- The Registration Office Act (Cap. 33)

Several other pieces of legislation impact on the work of the Registration Department.

The functions include but are not limited to:

- Receive all court documents
- Prepare case files for trial in the following court systems:
 - Appeals, Criminal, Civil and Family.
- Process application for grants of Probate and Letters of Administration.
- Register of Births, Stillbirths, Deaths and Marriages.
- Register Professional persons.
- Record Deeds such as Powers of Attorney, Deed Polls and deeds not pertaining to land.
- Supply authentic copies of documents and public records on the request and payment of the appropriate fee.
- Research and prepare certificates of births, deaths and marriages
- Process of Liquor Licences.
- Collect fees and fines imposed by the Magistrates.
- Collect and disburse maintenance money.
- Perform Notary functions
- Serve Court documents.

The functions of the Supreme Court, the Magistrates' Courts and the Court Process Office are all paper based and are carried out manually. A computerized system was implemented in the Records Branch to automate the processes of registering births, deaths and marriages as well as the processes for searching and retrieving of information in respect of births, deaths and marriages certificates. The process of preparing and printing of certificates is also automated.

VOLUME OF LITIGATION

SUPREME COURT

The Court of Appeal

During 2007, **27** Civil Appeals (High Court) were filed as compared with **32** in 2006 and **40** in 2005. **15** Civil Appeals (Magisterial) were filed as compared with **10** in 2006 and **7** in 2005.

There were **19** Criminal Appeals (High Court) filed in 2007 as compared with **20** in 2006 and **36** in 2005. **7** Magisterial Criminal Appeals as compared with **7** in 2006 and **5** in 2005.

In addition the Court of Appeal heard **80** Appeals, **90** Decisions were given and **80** Chambers Applications were disposed of.

The High Court

In the High Court **2396 Civil Cases** filed as compared with **2296** in 2006 and **2490** in 2005. **1048 Probate Applications** filed as compared with **1068** in 2006 and **1102** in 2005. (*Table 8 shows the number of cases filed in the High Court for the years 2003-2007*)

On the Criminal side, there were **201** indictments as compared with **125** in 2006 and **130** in 2005. *Table 10 shows the classification of Criminal cases filed in 2007.*

464 Divorce petitions were filed as compared with **494** in 2006 and **501** in 2005. The divorce rate was **16.76** per 100 marriages. (*See Tables 8 and 20*)

Table 11 shows the relative age of the husband and wife at the date of the presentation of their divorce.

In 2007, the number of children affected by Divorces according to *Section 3 of the Family Law Act Cap. 214* were **285**. The corresponding number for 2006 was **332** as compared with **328** in 2005. (*See Table 12*)

Other Family Applications

9 applications involving **Unions** were filed as compared with **2** in 2006 and **18** in 2005; **47 Custody** applications as compared with **53** in 2006 and **29** in 2005; **3 Annulments** as compared with **3** in 2006 and **4** in 2005; Applications for **Paternity** were **37** as compared with the same number in 2006 and **41** in 2005; there were **91** applications for **Maintenance** as compared with **91** in 2006 and **81** in 2005; **24** applications were made in respect of **Property Settlement** as compared with **23** in 2006 and **11** in 2005; **3** applications for **Adoptions** as compared with **7** in 2006 and **4** in 2005; **33 miscellaneous** family applications were filed as compared with **27** in 2006 and **28** in 2005. (*See Table 9*)

MAGISTRATES' COURTS

The Magistrates' Courts are courts of summary jurisdiction where a Magistrate acting without a jury can conduct cases without much delay or formality. The Magistrates' Courts are located at various districts throughout the Island.

During the year 2007 a total of 5277 Criminal cases, **12171** Traffic Cases, **3381** Civil cases, and **1642** Domestic cases as well as **100** Juvenile cases were lodged.

255 Protection Orders were lodged under the *Domestic Violence Act Cap. 130 of the Laws of Barbados*. **4152** cases were previously lodged making a total of **4407** cases lodged from the commencement of the act to the end of 2007.

Disposition of Cases

Cases disposed of were **4661** Criminal cases, **6133** Traffic cases **1866** Civil cases, **2872** Domestic cases, **97** Juvenile cases and **341 Protection Orders**. The Island Coroner held **30 Inquests** into deaths of persons who died of unnatural causes.

The two (2) Criminal Courts at District 'A' disposed of **1938** Criminal cases as compared with **2727** in 2006. In addition these courts disposed of **101** Traffic cases, **11** Civil cases, **67** Domestic Violence cases and **1** Juvenile case. In the District 'A' Traffic court **2757** cases were disposed of as compared with **12634** in 2006. In addition **3** Civil cases and **73** Domestic Violence cases were disposed of in this court. District A Civil disposed of **1606** cases as compared with **1686** in 2006. District 'A' Domestic disposed of **1434** cases as compared with **1723** 2006. Figures for District 'B' (Boarded Hall) showed **1575** cases as compared with **2361** in 2006. District B' (Oistins) disposed of **1178** cases as compared with **1553** in 2006. District 'C' disposed of **831** as compared with **857** in 2006. District 'D' disposed of **498** as compared with **672** in 2006. District 'E' disposed of **1024** cases as compared with **816** in 2006. District 'E' (Holetown) disposed of **1588** cases as compared with **908** in 2006. District 'F' (Horse Hill) disposed of **295** cases as compared with **245** in 2006. District 'F' (Belleplaine) disposed of **281** cases as compared with **241** in 2006. **74** Juvenile cases were adjudicated in the Juvenile Court.

Tables 15-16 show the cases lodged and adjudicated in the Magistrates' Courts.

RECORDS BRANCH

REGISTRATIONS

Population

At the end of the year 2007, the population of Barbados was estimated at approximately **274,746**. During the year births exceeded deaths by **1296**.

The growth of population covering a period of 5 years is shown as appended in Table 18. This table also shows the census figures taken on 1st May 2000.

The mid-year population in which several rates of births, deaths and marriages are calculated was 274,197. (*See Tables 20 and 21.*)

The size of Barbados is **166.55** square miles or acreage of **106,592**.

The Island is divided into eleven parishes with the principal City of Bridgetown in the parish of St. Michael.

The density per square mile for the Island is **1649.63** as compared with **1645.07** in 2006.

Registration of Births

Live births registered during the year were **3603** with males numbering **1873** and females **1730**. (*See Table 19*).

The birth rate was **13.14** per one thousand of the mid-year population. (*See Table 20*).

Live Birth Order: Age of mother and order of birth is shown in Table 23.

There were **31** cases of twins registered during 2007 as compared with **39** in 2006 and **27** in 2005. There were no recorded cases of triplets during the year 2007.

The number of **stillbirth** registrations was **25** with males numbering **15** and females **10**. (*See Tables 26 and 27*).

The **stillbirth** rate was **6.94** per 1000 of live births. (*See Table 20*).

Fertility

The respective age groups of mother and order of birth of their children are set out in Table 23. There were **11** births to mothers under the age of **15** years as compared with **3** in 2006 and **5** in 2005.

Female births for the year numbered **1730** as compared with **1669** in 2006 and **1801** in 2005.

Adoption

During the year under review 3 children were adopted under the provisions of the *Adoption Act Chapter 212* of the Laws of Barbados. **369** were previously adopted making a total of **372** from the commencement of the Act to the end of the year.

Registration of Deaths

2307 deaths were registered. Males were **1199** and females **1108**. The death rate was **8.41** per 1000 of the mid-year population. (*See Tables 19 and 20*).

There were 41 deaths under the age of one year. There were 23 males and 18 females 18 or **1.78 %** of the total deaths. (*See Tables 27, 28 and 29*).

The maternal mortality rate for 2007 is not yet available.

There were **658** deaths of persons of the age **85** years and over as compared **667** in 2006. (*See Table 28*). There were **27** deaths of persons over the age of 100.

The Cause of death as classified under 17 heads or groups for the years 2004-2007 is not yet available.

The International lists of causes are included in the report of the Director of Medical Services for the year.

Registration of Marriages

There were **2768** marriages registered during 2007. Of the contracting parties **1983** were *bachelors*, 2054 *spinsters*, 43 widowers, 35 *widows*, 742 *divorced men* and 679 *divorced women*. There were no incidents of the status of the male not being stated and no incidents of the female not being stated. (*See Tables 29 and 30*)

The *marriage rate* is **10.57** as shown in Table 17.

The relative ages of the brides and bridegrooms are shown in Table 31. Marriages by month of occurrences are included in Table 28

There was a 4.22% decrease in marriages as compared to 2006. The register shows no males and no females signed their name by his/her mark. The respective number for each category in 2006 was no males and no females.

Civil marriages, which were performed by the several Magistrates, numbered 295. (See Table 20)

- **Medical Register**

422 Medical Practitioners re-registered in January 2007 and 10 registered for the first time in January 2007 making a total of 432 persons gazetted in February 2007. No Medical Practitioners re-registered late and 70 registered for the first time during February to December 2007. *There were therefore 502 names on the Medical Register on 31st December 2007.*

The names of 37 Medical Practitioners were Provisionally registered, 8 Medical Practitioners were Specially registered and 4 Medical Practitioners were Temporarily registered.

3 Acupuncturists re-registered in January 2007 and no Acupuncturists registered for the first time in January 2007 making a total of 3 names published as at 31 January 2007. 2 Acupuncturists registered for the first time during February to December 2007. **There were therefore 5 names on the Paramedical Register-Acupuncturists on 31 December 2007.**

2 Cardiac Technologists re-registered in January 2007 and no Cardiac Technicians registered for the first time in January 2007 making a total of 2 names published as at January 2007. No Cardiac Technologists registered for the first time during February to December. **There were therefore 2 names on the Paramedical Register-Cardiac Technologists on 31 December 2007.**

2 Chiropodists re-registered in January 2007 and none registered for the first time in January 2007 making a total of 2 names published as at 31 January 2007. No Chiropodists registered for the first time during February to December 2007. **There were therefore 2 names on the Paramedical Register – Chiropodist on 31 December 2007**

5 Chiropractors re-registered in January 2007 and no Chiropractors registered for the first time in January 2007 making a total of 5 names published as at the 31 January 2007. No Chiropractors registered for the first time during February to December 2007. **There were therefore 5 names on the Paramedical Register-Chiropractors on 31 December 2007.**

1 Clinical Psychologist re-registered in January 2007 and no Clinical Psychologists registered for the first time in January 2007. 1 name was published as at 31 January 2007. No Clinical Psychologists registered for the first time during February to December 2007. **There was therefore 1 name on the Paramedical Register-Clinical Psychologist on 31st December 2007.**

32 Medical Laboratory Technologists re-registered in January 2007 and no Medical Laboratory Technologists registered for the first time in January 2007 making a total of 32 names published as at 31 January 2007. 11 Medical Laboratory Technologists registered for the first time during February to December 2007. **There were therefore 43 names on the Paramedical Register –Medical Laboratory Technologists on 31 December 2007.**

7 Occupational Therapists re-registered in January 2007 and no Occupational Therapists registered for the first time in January making a total of 7 names published as at 31 January 2007. 3 Occupational Therapists registered for the first time during February to December 2007. **There were therefore 10 names on the Paramedical Register- Occupational Therapist on 31 December 2007.**

1 Orthopedist re-registered in January 2007 and no Orthopedist registered for the first time in January 2007. There was therefore 1 name published as at 31 January 2007. No Orthopedist registered for the first time during February to December. **There**

was therefore 1 name on the Paramedical Register- Orthopedist on 31 December 2007.

12 Optometrists re-registered in January 2007 and no Optometrists registered for the first time in January 2007 making a total of 12 names published as at 31 January 2007. 2 Optometrists registered for the first time during February to December 2007. **There were therefore 14 names on the Paramedical Register – Optometrists on 31 December 2007.**

8 Ophthalmic Dispensers re-registered in January 2007 and no Ophthalmic Dispensers registered for the first time during January 2007 making a total of 8 names published as at 31 January 2007. 1 Ophthalmic Dispenser registered for the first time during February to December 2007. **There were therefore 9 names on the Paramedical Register-Ophthalmic Dispensers on 31 December 2007.**

No Nutritionists re-registered in January 2007 and no names were published as at 31 January 2007. No Nutritionists registered for the first time during February to December 2007. **There were no names on the Paramedical Register – Nutritionists on 31 December 2007.**

34 Physiotherapists re-registered in January 2007 and no Physiotherapists registered for the first time in January 2007 making a total of 34 names published as at 31 January 2007. 3 Physiotherapists registered for the first time during January to December 2007. **There were therefore 37 names on the Paramedical Register-Physiotherapists on 31 December 2007.**

3 Dieticians re-registered in January 2007 and no dieticians registered for the first time in January 2007 making a total of 3 names published as at 31 January 2007. No Dieticians registered for the first time during February to December 2007. **There were therefore 3 names on the Paramedical Register – Dieticians on 31 December 2007.**

3 Reflexologists re-registered in January 2007 and no Reflexologists registered for the first time in January 2007 making a total of 3 names published as at 31st January 2007. 3 Reflexologists registered for the first time during February to December 2007. **There were therefore 6 names on the Paramedical Register-Reflexologists on 31 December 2007.**

23 Diagnostic Radiographers re-registered in January 2007 and no Diagnostic Radiographers registered for the first time in January 2007 making a total of 23 names published as at 31st January 2007. 1 Diagnostic Radiographer registered for the first time during February to December 2007. **There were therefore 24 names on the Paramedical Register- Diagnostic Radiographers on 31 December 2007.**

4 Therapeutic Radiographers re-registered in January 2007 and no Therapeutic Radiographers registered for the first time in January 2007 making a total of 4 names published as at 31 January 2007. No Therapeutic Radiographers registered for the

first time during February to December 2007. **There were therefore 4 names on the Paramedical Register- Therapeutic Radiographers on 31 December 2007.**

1 Osteopath re-registered in January 2007 and 1 name was published as at 31 January 2007. 1 Osteopath registered for the first time during February to December 2007. **There were therefore 2 names on the Paramedical Register – Osteopath on 31 December 2007.**

5 Speech Therapists re-registered in January 2007 and no Speech Therapists registered for the first time in January 2007 making a total of 5 names published as at 31 January 2007. 1 Speech Therapist registered for the first time during February to December 2007. **There were therefore 6 names on the Paramedical Register – Speech Therapists on 31 December 2007.**

15 Psychologists re-registered in January 2007 and no Psychologists registered for the first time in January 2007 making a total of 15 names published as at 31st January 2007. 4 Psychologists registered for the first time during February to December 2007. **There were therefore 19 names on the Paramedical Register- Psychologists on 31 December 2007.**

- **Dental Hygienists Register**

14 Dental Hygienist re-registered in January 2007 and none registered for the first time in January 2007 making a total of 14 names gazetted in February 2007. No Dental Hygienists re-registered late and 2 registered for the first time during February to December 2007. **There were therefore 16 names on the Dental Hygienist Register on the 31st December 2007.**

- **Dental Technicians Register**
11 Dental Technicians re-registered in January 2007 and none registered for the first time in January 2007 making a total of 11 names gazetted in February 2007. No Dental Technicians re-registered late and none registered for the first time during February to December 2007. **There were therefore 11 names on the Dental Technicians Register on 31st December 2007.**
- **Veterinary Surgeons Register**
30 Veterinary Surgeons re-registered in January 2007 in List "A" and **none** in List "B". No Veterinary Surgeon registered for the first time during January 2007 making a total of 30 names gazetted in February 2007.
