INTRODUCTION

AN OVERVIEW OF THE REGISTRATION DEPARTMENT

Composition of the Registration Department is traditionally divided into four (4) functional sections or units, namely:

1. **The Supreme Court** which comprises:

i. The Court of Appeal

ii. The High Court

i. **The Court of Appeal** is presided over by Justices of Appeal and mainly deals with Appeals from the High Courts and Magistrates' Courts. The Chief Justice is President of the Court of Appeal.

ii. **The High Courts** are presided over by the Judges of the High Court and deal with Civil and Family matters as well as Criminal offences that are committed for trial by the Magistrates' Courts.

2. **The Magistrates' Courts**

The Magistrates' Courts are courts of summary jurisdiction where a Magistrate acting without a jury conducts cases without delay or formality. Magistrates' Courts are located at the various districts throughout the island.

3. **The Court Process Office**

The Court Process Office has responsibility for the execution of Writs, Orders, Levies for debt and serving of Summonses and other documents or process required to be served by the Rules of the Court. Its authority is derived from the Court Process Act Cap. 111A of the Laws of Barbados..

4. **The Records Branch**

The Records Branch also referred to as the island's registry is responsible for the registration of vital statistics records, i.e. births, deaths, marriages and professional registrations.

The Registrar of the Supreme Court is responsible for the administration of the Registration Department.

FUNCTIONS OF THE DEPARTMENT

The functions of the Registration Department are set out in various pieces of legislations, namely:

- The Supreme Court Act (Cap 117A)
- Civil Procedure Rules 2008
- The Magistrates' Courts Act (Cap 116A)
- The Court Process Office Act (Cap 111A)
- The Registration Office Act (Cap. 33)

Several other pieces of legislation impact on the work of the Registration Department.

The functions include but are not limited to:

- Receiving all court documents
- Preparing case files for trial in the following court systems:
 - o Appeals, Criminal, Civil and Family.
- Processing application for grants of Probate and Letters of Administration.
- Registering of Births, Stillbirths, Deaths and Marriages.
- Registering Professional persons.
- Recording Deeds such as Powers of Attorney, Deed Polls and deeds not pertaining to land.
- Preparing and supplying authentic copies of documents and public records on the request and payment of the appropriate fee.
- Researching and preparing certificates of births, deaths and marriages
- Processing of Liquor Licences.
- Collecting fees and fines imposed by the Magistrates.
- Collecting and disbursing child maintenance money.
- Performing Notary functions
- The Service of all Court documents.

Some of the functions of the Supreme Court, the Magistrates' Courts and the Court Process Office are paper based and are carried out manually. A Judicial Enforcement Management System was implemented in the Supreme Court registry to assist with the management of cases from filing to disposition. An Electronic Document management System is implemented in the Records Branch to automate the processes of registering births, deaths and marriages as well as the processes for searching and retrieving of information in respect of births, deaths and marriages certificates. The process of preparing and printing of certificates is also automated.

SUPREME COURT – VOLUME OF LITIGATION

THE COURT OF APPEAL

During 2009, **23** Civil Appeals (High Court) were filed as compared with **22** in 2008 and **27** in 2007. **8** Civil Appeals (Magisterial) were filed as compared with **11** in 2008 and **15** in 2007.

12 Criminal Appeals (High Court) were filed compared with **25** in 2008 and **19** in 2007; there were no Magisterial Criminal Appeals as compared to **2** in 2008 and **7** in 2007.

In addition the Court of Appeal heard **62** Appeals, **56** decisions were given and **25** Chamber Applications were disposed of.

Tables 1 to 4 set out the the volume of Appeals and pac of disposals for the year 2009

THE HIGH COURT

The number of Civil cases filed in the High Court during 2009 was **2104** as compared with **2099** in 2008 and **2396** in 2007. **1031** Probate applications were filed as compared with **1201** in 2008 and **1048** in 2007.

On the Criminal side there were **193** indictments as compared to **251** in 2008 and **201** in 2007.

440 Divorce petitions were filed as compared with **485** in 2008 and **464** in 2007. The Divorce rate was **18.25** per 100 marriages. *See Tables 8 and 20.*

The number of children affected by Divorces under Section 3 of the Family Law Act Cap. 214 was **298** in 2009. The corresponding number for 2008 was **312** as compared with **282** in 2007.

Other Family Applications

5 applications involving **Unions** were filed as compared with **10** in 2008 and **9** in 2007; **52** **Custody** applications as compared with **53** in 2008 and **47** in 2007; There were no **Annulments** in 2009 and 2008 as compared with **3** in 2007; Applications for **Paternity** were **48** as compared with **51** in 2008 and **42** in 2007; **69** applications for **Maintenance** were filed as compared with **63** in 2008 and **91** in 2007; **17** applications for **Property** settlement were filed as compared with **17** in 2008 and **24** in 2007; **5** applications for **Adoptions** as compared with **3** in 2008 and **3** in 2007. There were **38** miscellaneous applications as compared with **44** in 2008 and **33** in 2007.

THE MAGISTRATES' COURTS

The Magistrates' Courts of summary jurisdiction where a Magistrate acting without a jury can conduct cases without much delay or formality. The Magistrates' Courts are located at various districts throughout the island.

During the year 2009 a total of **5167** Criminal cases, **12 222** traffic cases, **3507** Civil cases, **1852** Domestic cases and **120** Juvenile cases were lodged.

• DISPOSITION OF CASES

The two (2) Criminal Courts at District 'A' disposed of **1404** criminal cases as compared with **1940** in 2008. District 'A' Traffic disposed of **4150** cases as compared with **4652** in 2008. District 'A' Civil disposed of **796** cases as compared with **1751** in 2008. District 'A' Domestic disposed of **1481** cases as compared with **1703** in 2008. District 'B', Boarded Hall disposed **1480** as compared with **1386** in 2008. District 'B' (Oistins) disposed of **1122** cases as compared with **1270** in 2008. District 'C' disposed of **986** cases as compared with **903** in 2008. District 'D' disposed of **496** cases as compared with **479** in 2008. District 'E' disposed of **24** civil cases. No other figures were available for cases adjudicated at this court. District 'E', Holetown disposed of **22** civil cases. No other figures were available for cases adjudicated at this court. District 'F' disposed of **271** cases as compared with **302** in 2008. District 'F', Belleplaine disposed of **160** cases as compared with **190** in 2008.

182 Protection Orders were filed under the Domestic Violence Act Cap. 130 of the laws of Barbados. 4633 cases were previously filed making a total of 4815 cases filed from the commencement of the Act to the end of 2009.

225 Protection Orders were granted under the Domestic Violence Act, Cap. 130 of the Laws of Barbados.

A total of 111 Juvenile cases were disposed of as compared with 107 in 2007. There were 22 Coroner's Inquests completed.

Tables 15, 16 and 16A show the cases lodged and adjudicated in each Magistrate's Court.

RECORD BRANCH – CIVIL REGISTRATIONS

• POPULATION

At the end of the year 2009, the population of Barbados was estimated at approximately **275,719**. During the year births exceeded deaths by **1110**.

The growth of population covering a period of 5 years is shown as appended in Table 18.

The mid-year population from which several rates of births, deaths and marriages are calculated was **275,344**. *See tables 20 and 21*

The size of Barbados is **166.55** square miles or acreage of **106, 592**.

The Island is divided into eleven parishes with the principal City of Bridgetown in the parish of St. Michael.

The density per square mile for the Island was **1690.95** as compared with **1658.66** in 2008.

• REGISTRATION OF BIRTHS

Live births registered during the year were **3564** with males totaling **1798** and females **1766**. *See Table 26*

The birth rate is **12.94** per one thousand of the mid-year population. *See Table 20*

Live Birth Order: Age of mother and order of birth is shown *in Table 26*.

There are **42** cases of twins being registered during 2009 as compared with **26** in 2008 and **31** in 2007. There are no recorded cases of triplets during the year.

The number of stillbirth registrations in 2009 is **13** with males totaling **8**, females **4** and **1** for which the sex was not stated. *See Tables 29 and 30*

The stillbirth rate is **3.65** per 1000 of live births. **See Table 20**

• FERTILITY

The respective age groups of mothers and order of birth of their children are set out in Table 26. There are **2** births to mothers under the age of 15 years as compared to **8** in 2008 and **11** in 2007.

Female births for the year 2009 numbered **1766** as compared with **1759** in 2008 and **1730** in 2007.

• ADOPTION

5 children were adopted under the provisions on the Adoption Act Cap. 212 of the Laws of Barbados. 375 were previously adopted making a total of 380 from the commencement of the Act to the end of the year.

• REGISTRATION OF DEATHS

2454 deaths were registered in 2009. Males 1257 and females 1197. The death rate is 8.91 per 1000 of the mid-year population. *See Tables 19 and 20*

There are 30 deaths under the age of one year, males 21 and females 9. Infant deaths are 1.22 % of the total deaths. *See table 32.*

The maternal mortality rate for 2009 is not available.

There were 702 deaths of persons aged 85 and over as compared to 812 in 2008. There were 31 deaths of persons over the age of 100. *See Table 32*

The Causes of Death as classified under 17 heads or groups for the years 2006- 2009 are not yet available.

The International lists of causes are included in the report of the Director of Medical Services for the year.

• REGISTRATION OF MARRIAGES

There were 2411 marriages registered during 2009. Of the contracting parties 1754 were bachelors, 1840 spinsters, 56 widowers, 38 widows, 600 divorced men and 533 divorced women. There were no marriages registered with the status of the male and female not being stated. *See Table 35*

The relative ages of the bride and bridegrooms are shown in *Table 33*. Marriages by the month of occurrences are shown in *Table 31*. The marriage rate was 8.76 as shown in *Table 20*.

Marriages decreased by 9.83 % as compared with 2008. The register showed no male and no female signed his/her name by his/ her mark.

Civil marriages, which were performed by the several Magistrates, are 246. This is seen in *Table 23*.

471 Medical Practitioners re-registered in January 2009 and 8 registered for the first time in January 2008 making a total of 479 names published in February 2009. No Medical Practitioners re-registered late and 41 registered for the first time during February to December 2009. **There were therefore 520 names on the Medical Register on 31st December 2009.**

The names of **35** Medical Practitioners were **Provisionally** registered, 4 Medical Practitioners were **Specially** registered and **4** Medical Practitioners were **Temporarily** registered.

4 Acupuncturists re-registered in January 2009 and no Acupuncturists registered for the first time in January 2009 making a total of 4 names published in February 2009. No Acupuncturists registered for the first time during February to December 2009. **There were therefore 4 names on the Paramedical Register- Acupuncturists on 31 December 2009**

1 Audiologist re-registered in January 2009 and none registered for the first time in January 2009 therefore 1 name was published in February 2009. No Audiologists re-registered late and none registered for the first time during February to December 2009. **There was therefore 1 name on the Paramedical Register-Audiologists on 31st December 2009.**

3 Cardiac Technologists re-registered in January 2009 and no Cardiac Technicians registered for the first time in January 2009 making a total of 3 names published in February 2009. No Cardiac Technologists registered for the first time during February to December 2009. **There were therefore 3 names on the Paramedical Register-Cardiac Technologists on 31 December 2009.**

1 Chiropodist re-registered in January 2009 and none registered for the first time in January 2009 making a total of 1 name published in February 2009. No Chiropodists registered for the first time during February to December 2009. **There was therefore 1 name on the Paramedical Register – Chiropodist on 31 December 2009.**

5 Chiropractors re-registered in January 2009 and no Chiropractors registered for the first time in January 2009 making a total of 5 names published in February 2009. No Chiropractors registered for the first time during February to December 2009. **There were therefore 5 names on the Paramedical Register-Chiropractors on 31 December 2009.**

5 Clinical Psychologists re-registered in January 2009 and no Clinical Psychologists registered for the first time in January 2009. 5 names were published in February 2009. 1 Clinical Psychologist registered for the first time during February to December 2009. **There were therefore 6 names on the Paramedical Register-Clinical Psychologists on 31st December 2009.**

44 Emergency Medical Technicians re-registered in January 2009 and none registered for the first time in January making a total of 44 named published in February 2009. No Emergency Medical Technicians re-registered late and 5 registered for the first time during February to December 2009. **There were therefore 49 names on the Paramedical Register- Emergency Medical Technicians on 31st December 2009.**

35 Medical Laboratory Technologists re-registered in January 2009 and no Medical Laboratory Technologists registered for the first time in January 2009 making a total of 35 names published in February 2009. 5 Medical Laboratory Technologists registered for the first time during February to December 2009. **There were therefore 40 names on the Paramedical Register –Medical Laboratory Technologists on 31 December 2009.**

7 Occupational Therapists re-registered in January 2009 and no Occupational Therapists registered for the first time in January 2009 making a total of 7 names published in February 2009. No Occupational Therapists re-registered late and 3 Occupational Therapists registered for the first time during February to December

2009. **There were therefore 10 names on the Paramedical Register-Occupational Therapists on 31 December 2009.**

1 Orthoptist re-registered in January 2009 and no Orthoptist registered for the first time in January 2009. There was therefore 1 name published in February 2009. No Orthoptist registered for the first time during February to December 2009. **There was therefore 1 name on the Paramedical Register- Orthoptists on 31 December 2009.**

15 Optometrists re-registered in January 2009 and no Optometrists registered for the first time in January 2009 making a total of 15 names published in February 2009. No Optometrists registered for the first time during February to December 2009. **There were therefore 15 names on the Paramedical Register – Optometrists on 31 December 2009.**

8 Ophthalmic Dispensers re-registered in January 2009 and no Ophthalmic Dispensers registered for the first time during January 2009 making a total of 8 names published in February 2009. No Ophthalmic Dispensers registered for the first time during February to December 2009. **There were therefore 8 names on the Paramedical Register-Ophthalmic Dispensers on 31 December 2009.**

No Nutritionists re-registered in January 2009 and no names were published in February 2009. No Nutritionists registered for the first time during February to December 2009. **There were no names on the Paramedical Register – Nutritionists on 31 December 2009.**

36 Physiotherapists re-registered in January 2009 and no Physiotherapists registered for the first time in January 2009 making a total of 36 names published in February 2009. 2 Physiotherapists registered for the first time during January to December 2009. **There were therefore 38 names on the Paramedical Register-Physiotherapists on 31 December 2009.**

- **DENTAL REGISTER**

64 Dentists re-registered in January 2009 and none registered for the first time in January 2009 making a total of 64 names gazetted in February 2009. No Dentists re-registered late and 4 registered for the first time during February to December 2009. **There were therefore 68 names on the Dental Register on the 31st December 2009.**

- **DENTAL AUXILIARIES REGISTER**

No Dental Auxiliaries re-registered in January 2009 and none registered for the first time in January 2009 therefore no names were published in February 2009.
