INTRODUCTION

The Registration Department is traditionally divided into four (4) functional sections or units, namely:

1. THE SUPREME COURT

The Supreme Court comprises:

- A. The Court of Appeal
- B. The High Court
- A. **THE COURT OF APPEAL** is presided over by Justices of Appeal and mainly deals with Appeals from the High Courts and Magistrates' Courts. The Chief Justice is President of the Court of Appeal.
- B. **THE HIGH COURTS** are presided over by the Judges of the High Court and deal with Civil and Family matters as well as Criminal offences that are committed for trial by the Magistrates' Courts.

2. THE MAGISTRATES' COURTS

The Magistrates' Courts are courts of summary jurisdiction where a Magistrate acting without a jury conducts cases without delay or formality. Magistrates' Courts are located at the various districts throughout the island.

3. THE COURT PROCESS OFFICE

The Court Process Office has responsibility for the execution of Writs, Orders, Levies for debt and serving of Summonses and other documents or process required to be served by the Rules of the Court. Its authority is derived from the Court Process Act Cap. 111A of the Laws of Barbados.

4. THE RECORDS BRANCH

The Records Branch also referred to as the island's registry is responsible for the registration of vital statistics records, i.e. births, deaths, marriages and professional registrations.

The Registrar of the Supreme Court is responsible for the administration of the Registration Department.

SUPREME COURT – VOLUME OF LITIGATION

COURT OF APPEAL

During 2010, **17** Civil Appeals (High Court) were filed as compared with **23** in 2009 and **22** in 2008. **8** Civil Appeals (Magisterial) were filed as compared with **8** in 2009 and **11** in 2008.

There were **25** Criminal Appeals (High Court) filed as compared with **12** in 2009 and **25** in 2008; and **5** Magisterial Criminal Appeals as compared to none in 2009 and **2** in 2008.

In addition the Court of Appeal heard **70** Appeals, **27** decisions were given and **14** Chamber Applications were disposed of.

Tables 1-4 set out the volume of appeals and pace of disposals for the year 2010. Tables 5-8 compare similar information for the years 2005 to 2010.

THE HIGH COURT

In the High Court **1760** Civil cases were filed compared with **2104** in 2009 and **2099** in 2008. **1071** Probate applications were filed as compared with **1031** in 2009 and **1201** in 2008.

Table 8 shows the number of cases filed in the High Court for the years 2006 – 2010.

On the Criminal side there were **213** indictments as compared to **193** in 2009 and **251** in 2008. Table 10 shows the classification of Criminal cases filed.

462 Divorce petitions were filed as compared with **440** in 2009 and **485** in 2008. The Divorce rate was **18.48** per 100 marriages. *See Tables 8 and 20.*

Table 11 shows the relative age of husband and wife at the date of the presentation of their divorce.

The number of children affected by Divorces according to Section 3 of the Family Law Act, Cap 214 were **302** in 2010. The corresponding number for 2009 was **298** as compared with **312** in 2008. *See table 12.*

11 applications involving **Unions** were filed as compared with **5** in 2009 and **10** in 2008; **49** **Custody** applications as compared with **53** in 2009 and **53** in 2008; **1** **Annulment** as compared with **0** in 2009 and **0** in 2008; **Paternity** applications were **32** as compared with **48** in 2009 and **51** in 2008; **60** applications for **Maintenance** were filed as compared with **69** in 2009 and **63** in 2008; **16** applications for **Property** settlement were filed as compared with **17** in 2009 and **17** in 2008; **6** applications for **Adoptions** as compared with **5** in 2009 and **3** in 2008; and **37** miscellaneous applications as compared with **38** in 2009 and **44** in 2008. *See table 9.*

THE MAGISTRATES' COURTS – VOLUME OF LITIGATION

The Magistrates' Courts of summary jurisdiction where a Magistrate acting without a jury can conduct cases without much delay or formality. The Magistrates' Courts are located at various districts throughout the Island.

During the year 2010 a total of **5372** Criminal cases, **15119** Traffic cases, **3609** Civil cases, **1899** Domestic cases and **87** Juvenile cases were lodged.

The two (2) Criminal Courts at District 'A' disposed of **1736** criminal cases as compared with **1404** in 2009. District Traffic disposed of **2864** cases as compared with **4150** in 2009. District 'A' Civil disposed of **1417** cases as compared with **796** in 2009. District 'A' Domestic disposed of **1316** cases as compared with **1481** in 2009. Figures for District 'B' (Boarded Hall) disposed **1336** as compared with **1480** in 2009. District 'B' (Oistins) disposed of **836** cases as compared with **1122** in 2009. District 'C' disposed of 875 cases as compared with **986** in 2009. District 'D' disposed of **511** cases as compared with **496** in 2009. District 'E' disposed of **45** civil cases. No other figures were available for cases adjudicated at this court. A total of **1024** cases were adjudicated in 2007. District 'E' (Holetown) disposed of **25** civil cases. No other figures were available for cases adjudicated at this court. District 'F' disposed of **289** cases as compared with **271** in 2009. District 'F' (Belleplaine) disposed of **195** cases as compared with **160** in 2009.

190 Protection Orders were filed under the Domestic Violence Act, Cap. 130 of the laws of Barbados 4815 cases were previously filed making a total of 5005 cases filed from the commencement of the Act to the end of 2010.

263 Protection Orders were granted under the Domestic Violence Act, Cap 130 of the Laws of Barbados.

Tables 15 and 16 show the cases lodged and adjudicated in each Magistrate's Court.

RECORD BRANCH

CIVIL REGISTRATIONS

POPULATION

At the end of the year 2010, the population of Barbados was estimated at approximately **276302**. During the year births exceeded deaths by 1115.

The growth of population covering a period of 5 years is shown as appended in Table 18. The figures only relate to the resident population of Barbados.

The mid-year population from which several rates of births, deaths and marriages are calculated was **276070**. See table20

The size of Barbados is 166.55 square miles or acreage of 106, 592.

The Island is divided into eleven parishes with the principal City of Bridgetown in the parish of St. Michael.

The density per square mile for the Island was **1664.46** as compared with **1660.95** in 2009.

REGISTRATION OF BIRTHS

Live births registered during the year are **3446** with males totaling **1830** and females **1616**. See Table 26.

The birth rate was **12.48** per one thousand of the mid-year population. See Table 20.

Live Birth Order: Age of mother and order of birth is shown in Table 26.

There were **43** cases of twins registered during 2010 as compared with **42** in 2009 and **26** in 2008. There were no recorded cases of triplets during the year.

There are no Still-births registered for the year 2010. The stillbirth rate is therefore 0 per 1000 of live births. See Table 20

FERTILITY

The respective age groups of mother and order of birth of their children are set out in Table 26. There are **3** births to mothers under the age of 15 years as compared to 2 in 2009 and **8** in 2008.

Female births for the year are **1616** as compared with **1766** in 2009 and **1759** in 2008.

ADOPTION

6 children were adopted under the provisions on the Adoption Act Chapter 212 of the Laws of Barbados. 380 were previously adopted making a total of 386 from the commencement of the Act to the end of the year.

REGISTRATION OF DEATHS

2331 deaths were registered in 2010. Males were **1158**, females **1173**. The death rate was 8.44 per 1000 of the mid-year population. See Tables 19 and 20

There were **33** deaths under the age of one year, males **14** and females **19**. Infant deaths were 9.58 % of the total deaths. See Tables 31.

The maternal mortality rate for 2010 is not available.

There were **668** deaths of persons over the age 85 and as compared to **702** in 2009. See Table 31. There were 14 deaths of persons over the age of 100.

The cause of death as classified under 17 heads or groups for the years 2006- 2010 are not yet available.

The International lists of causes are included in the report of the Director of Medical Services for the year.

REGISTRATION OF MARRIAGES

There were 2500 marriages registered during 2010. Of the contracting parties 1793 were bachelors, 1894 spinsters, 57 widowers, 37 widows, 650 divorced men and 569 divorced women. There were no marriages registered with the status of the male and female not being stated. See Table 34.

The relative ages of the brides and bridegrooms are shown in Table 33. Marriages by the month of occurrences are shown in Table 32. The marriage rate is 9.06 as shown in Table 20.

Marriages increased by 3.56 % as compared with 2009. The register showed no male and no female signed his/her name by his/ her mark.

Civil marriages, which were performed by the several Magistrates, were 259. See Table 23

456 Medical Practitioners re-registered in January 2010 and 3 registered for the first time in January 2010 making a total of 459 persons gazetted in February 2010. No Medical Practitioners re-registered late and 123 registered during February to December 2010. **There were therefore 582 names on the Medical Register on 31st December 2010.**

The names of 27 Medical Practitioners were **Provisionally** registered, 2 Medical Practitioners were **Specially** registered and 8 Medical Practitioners were **Temporarily** registered.

5 Acupuncturists re-registered in January 2010 and no Acupuncturists registered for the first time in January 2010 making a total of 5 names published. 1 Acupuncturist registered for the first time during February to December 2010. **There were therefore 6 names on the Paramedical Register- Acupuncturists on 31 December 2010.**

No Audiologists re-registered in January 2010 and none registered for the first time in January 2010 therefore were no names published in 2010. No Audiologists registered

late and 1 registered during February to December 2010. **There was therefore 1 name on the Paramedical Register-Audiologists on 31st December 2010.**

3 Cardiac Technologists re-registered in January 2010 and no Cardiac Technologists registered for the first time in January 2010 making a total of 3 names published in 2010. No Cardiac Technologists registered during February to December 2010. **There were therefore 3 names on the Paramedical Register-Cardiac Technologists on 31 December 2010.**

1 Chiropodist re-registered in January 2010 and none registered for the first time in January 2010 making a total of 1 name published in 2010. 1 Chiropodist registered during February to December 2010. **There were therefore 2 names on the Paramedical Register – Chiropodist on 31 December 2010.**

6 Chiropractors re-registered in January 2010 and none registered for the first time in January 2010 making a total of 6 names published in 2010. 1 Chiropractor registered during February to December 2010. **There were therefore 7 names on the Paramedical Register-Chiropractors on 31 December 2010.**

1 Orthoptist re-registered in January 2010 and none registered for the first time in January 2010. There was therefore 1 name published in 2010. No Orthoptist registered February to December 2010. **There was therefore 1 name on the Paramedical Register- Orthoptist on 31 December 2010.**

16 Optometrists re-registered in January 2010 and none registered for the first time in January 2010 making a total of 16 names published in 2010. No Optometrists registered during February to December 2010. **There were therefore 16 names on the Paramedical Register – Optometrists on 31 December 2010.**

8 Ophthalmic Dispensers re-registered in January 2010 and none registered for the first time during January 2010 making a total of 8 names published in 2010. 1 Ophthalmic

38 Physiotherapists re-registered in January 2010 and none registered for the first time in January 2010 making a total of 38 names published in 2010. 8 Physiotherapists registered during January to December 2010. **There were therefore 46 names on the Paramedical Register- Physiotherapists on 31 December 2010.**

134 Engineers re-registered in January 2010 and 5 registered for the first time in January 2010 making a total of 139 names published in 2010. No Engineers registered late and 7 Engineers registered during February to December 2010. **There were therefore 146 names on the Engineers Register on the 31st December 2010.**

71 Accountants re-registered in January 2010 and none registered for the first time in January 2010 making a total of 71 names published in 2010. No Accountants registered late and 1 Accountant registered during February to December 2010. **There were therefore 72 names on the Register of Accountants on 31st December 2010.**

REGISTER OF ARCHITECTS

58 Architects re-registered in January 2010 and none registered for the first time in January 2010 making a total of 58 names published in 2010. No Architects registered late and 11 Architects registered during February to December 2010. **There were therefore 69 names on the register of Architects on 31st December 2010.**
