ENACTED by the Parliament of Barbados as follows:

1. This Act may be cited as the *Appropriation Act, 2012*. Short title.

2. The Accountant-General may, on the warrant of the Minister responsible for Finance or a person authorised by the Minister in writing, issue out of the Consolidated Fund and apply towards making good the supply granted for the service of the financial year ending the 31st March, 2013 a sum not exceeding in the aggregate \$1,704,002,578.

3. The sum referred to in section 2 is hereby appropriated for the services and purposes set out in the *Schedule* in accordance with section 109(1) of the *Constitution* and shall be so appropriated from 1st April, 2012.
