Duties, Taxes and Other Payments (Exemption) Act Cap. 67B

DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION) (COUNTERPART CARIBBEAN INCORPORATED) ORDER, 2011

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

- 1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Counterpart Caribbean Incorporated) Order, 2011.*
- 2. Counterpart Caribbean Incorporated, a company incorporated under the *Companies Act*, is granted an exemption from the import duty Cap. 308. and environmental levy payable in respect of the audio visual equipment specified in the *Schedule* which was used during an educational Schedule. community development workshop held between 8th February, 2010 and 20th February, 2010.
- 3. This Order is deemed to have come into operation on the 3rd day of February, 2010.
