**Profession, Trade and Business Registration Act**  
**Cap. 373**

**PROFESSION, TRADE AND BUSINESS**  
**REGISTRATION ORDER, 2011**

The Minister, in exercise of the power conferred on him by section 13(a) of the *Profession, Trade and Business Registration Act*, makes the following Order:

1. This Order may be cited as the *Profession, Trade and Business Registration Order, 2011*.

2. Part II of the *Second Schedule* to the *Profession, Trade and Business Registration Act*, in this Order referred to as the principal Act, is amended by inserting in the appropriate alphabetical order the following:

Dietitian  
Nuclear Medical Technologist  
Nutritionist  
Orthoptist

3. The Third and Fourth Schedules to the principal Act are deleted and the Third and Fourth Schedules set out in the *Schedule* to this Order are substituted. Schedule.

4. This Order comes into effect on the 1st day of January, 2012.
