POST OFFICE (OVERSEAS PARCEL POST)
(AMENDMENT) REGULATIONS, 2011

The Minister, in exercise of the powers conferred on him by section 59 of the *Post Office Act*, makes the following Regulations:

1. These Regulations may be cited as the *Post Office (Overseas Parcel Post) (Amendment) Regulations, 2011*.

2. The First Schedule to the *Post Office (Overseas Parcel Post) Regulations, 1980* is deleted and the Schedule contained in the *Schedule* to these Regulations is substituted:
