DUTIES, TAXES AND OTHER PAYMENTS (REMIT) (BARBADOS CRUISING CLUB) ORDER, 2011

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act,* makes the following Order:

- 1. This Order may be cited as the *Duties, Taxes and Other Payments (Remit) (Barbados Cruising Club) Order, 2011.*
- 2. The Barbados Cruising Club is granted a remit from the payment of land tax under the Land Tax Act

 Cap. 78A.
 - (a) in the sum of \$6 884.15 for the period 1st April, 2010 to 31st March, 2011;
 - (b) in the sum of \$6 884.15 for the period 1st April, 2009 to 31st March, 2010;
 - (c) in the sum of \$6 884.15 and the interest thereon being the sum of \$72.28 and the penalty thereon being the sum of \$344.21 for the period 1st April, 2008 to 31st March, 2009;
 - (d) in the sum of \$6 884.15 and the interest thereon being the sum of \$939.64 and the penalty thereon being the sum of \$344.21 for the period 1st April, 2007 to 31st March, 2008;
 - (e) in the sum of \$6 884.15 and the interest thereon being the sum of \$1 807 and the penalty thereon being the sum of \$344.21 for the period 1st April, 2006 to 31st March, 2007;

- (s) in the sum of \$5 816.07 and the interest thereon being the sum of \$3 969.55 and the penalty thereon being the sum of \$290.80 for the period 1st April, 1992 to 31st March, 1993

for the parcel of land no. 88.02.03.001/4 which is in the name of the Crown.

- 3. The parcel of land, the property of the Crown, referred to in paragraph 2, was leased to the Barbados Cruising Club for a period of
 - (a) 25 years from 5th March, 1966 to 4th March, 1991; and
 - (b) 15 years from 5th March, 1992 to 4th March, 2007.
