- **1.** This Act may be cited as the *Passports and Travel Documents* Short title. (*Fees*) *Act*.
 - 2. For the purposes of this Act,

"Barbados passport" means a passport issued by or on behalf of the Government of Barbados to a citizen of Barbados;

"travel document" includes any visa, travel permit, certificate of identity or other similar document issued by or on behalf of the Government of Barbados.

3. (1) There shall be payable in respect of

Fees for passports

(a) the issue and renewal of Barbados passports;

and other travel

(b) the issue of travel documents; and

(c) any other matter mentioned in the *Schedule* such fees as are from time to time specified in the *Schedule*.

(2) The Minister may waive any fee payable under subsection (1) in respect of such categories of passports and travel documents as he thinks fit.

Variation of fees and other amendments to Schedule.

- **4.** (1) Subject to subsection (2), the Minister may from time to time by order published in the *Official Gazette* vary the fees specified in the *Schedule* or otherwise amend the *Schedule* in such manner as he considers appropriate.
- (2) Every order made under this section shall be subject to negative resolution.

Stamp Duty Act not to apply to passports and travel documents issued abroad. Cap. 91. **5.** Nothing contained in the *Stamp* Duty *Act* shall apply or be deemed to have applied to the issue abroad of any Barbados passport or travel document.
